SUBJECT: COVID-19 PID Office Closure

Dear Water Users and Landowners of the Patterson Irrigation District,

On Thursday, March 19, 2020, in response to the escalation of the COVID-19 virus, California Governor Gavin Newsom issued a mandatory stay at home order except for essential services. Water service for agriculture is considered an essential service, therefore irrigation deliveries will continue. However, to protect our staff in the Patterson Irrigation District (PID or District) office, as of March 20, 2020, the office will be closed to the public until further notice. Staff will be in the office to take your calls but will not be able to meet you in person. You can still order water through calling:

- The southside ditchtender at (209) 613-4892

Payments are still due, however, the District will not accept payments in person. The methods of which the District will accept your payments are provided below:
