This notice is provided pursuant to California Government Code Section 1780 to advise that the Patterson Irrigation District (PID) Board of Directors will consider nominations for the vacant position of Director at its Regular Board Meeting on August 17, 2022. The unexpired term of the vacant seat runs through the first Friday of December 2024, at which time the individual appointed will have the opportunity to run for a four year term of office.

To be eligible, candidates must be a voter and a landowner within PID, and a resident of PID Division 2 (generally bounded by the San Joaquin River to the east, Highway 33 to the west, Lemon Avenue to the north, and Las Palmas Avenue to the south).
