BOARD TO CONSIDER AUTHORIZING GENERAL MANAGER TO EXECUTE THE MEMORANDUM OF UNDERSTANDING WITH THE LOCAL 3 OPERATING ENGINEERS AND PID FIELD STAFF THROUGH DECEMBER OF 2025

Lucchesi noted that PID representatives are to meet again with the Union reps, some small tweaks were addressed and the representatives are working on those items.

BOARD TO CONSIDER SETTING THE END OF THE IRRIGATION SEASON AND APPROVAL OF LETTER TO PID ACCOUNT HOLDERS REGARDING THE END OF THE SEASON

General Manager Lucchesi presented to the Board the draft letter notifying all account holders of ending the irrigation season on October 20, 2023 so PID staff can move to winter maintenance.

After a thorough discussion, Director Scheuber made a motion to approve the end of the irrigation season to be October 20, 2023. Second by Director Fantozzi and passed unanimously.

BOARD TO CONSIDER AUTHORIZING THE GENERAL MANAGER TO EXECUTE CONTRACT WITH STANTEC ENGINEERING FOR ENGINEERING SERVICES DURING CONSTRUCTION, CONSTRUCTION MANGEMENT SERVICES, AND ENGINEERING MODIFICATIONS FOR PUMPING PLANT NUMBER 4

General Manager Lucchesi presented to the Board of Directors a proposal from Stantec for \$1,451,961.25. This proposal is for: engineering services change order for addressing some changes on the Pumping Plant 4 design, Construction Management Services, and Engineering Services during construction. Lucchesi noted that Stantec's proposal for engineering services during construction and construction management services are identical to the proposal for the Pumping Plant 2 work. Lucchesi noted that this effort is the same as Pumping Plant 2 and therefore these costs are in line with what we paid before.

Lucchesi also noted that although our purchasing policy has a requirement to go out to RFP for efforts in this price range; the single source justification is necessary to justify varying from the policy. Lucchesi noted that this work is a continuation of existing work performed by Stantec. In addition, Lucchesi stated that this work has been put to bid before and Stantec was the low bidder

and performed within budget without any change orders. Therefore, it is justifiable that the Board may allow the single source justification for the work.

After a thorough discussion, Director Azevedo made a motion to authorize the General Manager to execute the contract and make the necessary budget adjustments and to accept the single source justification. Second by Director Scheuber and passed unanimously.

BOARD TO CONSIDER AUTHORIZING GENERAL MANAGER TO EXECUTE WATER TRANSFER AGREEMENTS WITH KERN-TULARE WATER DISTRICT FOR UP TO 10,000 AF OF WATER ALLOCATED BY THE ENDTRAL VALLEY PROJECT AND EXECUTING AGREEMENTS AND ACTIONS NECESSARY TO FACILITATE THE TRANSFER THERETO

Lucchesi presented to the Board two transfer proposals from Kern-Tulare Water District for \$59.80 per acre-foot. The first transfer is for up to 4,000 AF of PID San Joaquin River Settlement water and up to 7,000 AF of PID's remaining CVP SOD Ag water supply. Both transfers are to have a cap of 10,000 AF.

After a brief discussion Director Azevedo made a motion to approve the transfers and to authorize the general manager to take actions necessary to facilitate the transfers. Seconded by Director Robinson and passed unanimously.
